

DEED OF RIGHT OF WAY OR EASEMENT

THIS INDENTURE, made this 29th day of October, in the year One Thousand Nine Hundred and Fifty-one, between A. W. CHILD and EMMA C. SLATER, husband and wife, as joint tenants and not as tenants in common, with full rights of survivorship, of the same place, parties of the second part,




WITNESSETH:

That the said A. W. Child and Emma C. Child, husband and wife, for and in consideration of the sum of One Hundred Twenty five (\$125.00) Dollars, unto them well and truly paid by the said W. Everett Slater and Erma C. Slater, husband and wife, and for other consideration, have granted, bargained and sold and do grant, bargain and sell unto the said W. Everett Slater and Erma C. Slater, husband and wife, aforesaid, a perpetual right of way or easement for a ditch in which to convey water from the water ditch or canal which runs on the East boundary of the Grantors property lying West of highway, over to and upon the property of the said W. Everett Slater and Erma C. Slater, husband and wife, said easement or right of way being described as follows:

A part of Lot 1, in Section 16, Township 5 North, Range 2 West, Local Survey: Beginning at a point on the East line of said Lot 1, 765 feet South from the Northeast corner of said Lot 1, a strip 6 feet wide, running thence West 120 feet to the Easterly line of said Slater property.
