RESOLUTION ACATING A PART OF CLOVERDALE ADDITION AND THE STREETS AND ALLEYS LOCATED THEREIN, AS NOW PLATTED AND DEDICATED IN WEBER COUNTY, STATE OF UTAR.

MHEREAS, all of the owners of the land contained in the entire Plat of Cloverdale Addition in Weber County, Utah, and all of the owners of the land contiguous or adjacent to every street and every alley contained in the part of said Plat hereinafter described, have petitioned the Board of County Commissioners of Weber County in writing, over the signatures of all of the above described owners, to vacate part of the Plat of Cloverdale addition, including the streets and alleys contained in that portion of the plat hereinafter described; and

WHEREAS, it appears to the Board of County Commissioners of Weber County that neither the public or the private individuals would be injured by vacating the hereinafter described part of said Cloverdale Addition and the streets and alleys contained therein;

NOW, THEREFORE, be it, and it is hereby RESOLVED AND ORDERED that the Plat of Cloverdale Addition in Weber County, Utah covering and encompassing:

All of Blocks 1, 3, 5, 7, 9, 11, 13, 15 and Lots 1 to 4 inclusive, and the small diagonal fraction of lot West of GTR & D Railroad in Block 17, all in CLOVERDALE ADDITION in Weber, County, State of Utah, and situate in the South Half of the Southwest Quarter of Section 2, Township 5 North, Range 2 West, Salt Lake Base and Meridian, U. S. Survey, as the said Cloverdale Addition who exists by reason of prior vacation of a portion of the plat of Cloverdale Addition, together with all of the lands contained within the dedicated streets, avenues alleys within the vacated portion of said plat and abutting upon the lands hereinbefore described,

be and the same is hereby vacated. All streets, alleys and avenues within the above described vacated portion of said Cloverdale Addition Plat and abutting upon the lands hereinbefore described, be and they are also hereby vacated as public roads or thoroughfares.

IT IS FURTHER ORDERED that the streets and alleys vacated by this resolution are to revert to the owners of the real property abutting thereon, as their interests may appear.

The County Clerk is hereby authorized and instructed to relinquish and quit claim any and all right, title and interest that Weber County has in the above described streets and alleys to the abutting property owners, as herein provided, upon presentation by the property owner to the Clerk of a properly prepared quit claim deed.

This Resolution and Order shall take effect immediately.
