Utah, by Wendell Hansen, County Clerk in and for said WEBER COUNTY, Grantor hereby grants to Wallace James Smith and Brooke Grant, a Right of Way for the purpose of ingress and egress to real property owned by grantees, their heirs and assigns, more particularly described as follows:

A part of the Northeast quarter of Section 9, Township 5 North, Range 1 West, Salt Lake Meridian, United States Survey: BEGINNING at a point 2312.64 feet South and 661.72 feet South 86° 12' West from the Northeast corner of said quarter section, and running thence South 86° 12' West 177.8 feet; thence North 34° 45' West 35 feet, more or less, to Grantor's property corner; thence North 3° 39' West 491 feet, more or less, to property line; thence North 5° 15' East 503.70 feet thence South 40° 13' East 169.04 feet; thence South 200.76 feet to a point 72.70 feet West and 685.91 feet North of the point of beginning; thence East 72.70 feet; thence South 685.91 feet to the point of beginning.

SAID RIGHT OF WAY, located in Weber County, State of Utah is more particularly described as follows:

A part of the Northeast Quarter of Section 9, Township 5 North, Range 1 West, Salt Lake Base and Meridian, U.S. Survey: Beginning at a point 2312.64 feet South and 661.72 feet South 86° 12' West from the Northeast Corner of said Quarter Section and running thence South 86° 12' West 177.3 feet thence North 34° 45' West 35 feet thence North 3° 39' West 491 feet thence North 5° 15' East 510.85 feet to the South line of Old County Road, and true point of beginning, thence South 40° 15' East along said South line of road 28 feet; thence N 49° 45' E 25 feet to South line of Country Hills Drive thence to the right along said drive 28 feet to a point N 5° 15' E from the point of beginning, thence S 5° 15' W. 20 feet to the point of beginning.


THIS EASEMENT is given pursuant to a resolution of the Board of County Commissioners of said Weber County passed on the 31st day of May, 1973.
