# SECOND AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR THE FIELDS SUBDIVISION

- B. The Declarant executed that certain First Amendment to Declaration of Covenants, Conditions, and Restrictions for The Fields Subdivision, which document was recorded in the Davis County Recorder's office on November 21, 2019 as Entry No. 3205369 in Book 7394 at Pages 331-334 (the "First Amendment").
- C. This Amendment affects the Project commonly known as The Fields Subdivision located in Syracuse City ("City"), Davis County ("County"), State of Utah.
  - D. The Declarant desires to amend the Declaration as set forth in this Amendment.
- E. Pursuant to Section 12.2 of the Declaration, during the Period of Declarant's Control, the Declarant has the right to amend the Declaration without the consent of any other Owner. As of the Effective Date, the Period of Declarant's Control remains in full force and effect.

#### AMENDMENTS

NOW, THEREFORE, in consideration of the foregoing Recitals, the Declarant hereby executes this Amendment, which shall be effective as of its recording date with the Davis County Recorder's office.

- Expansion of the Project. Additional phases of the Project have been, or are being, developed and, pursuant to Section 2.5 of the Declaration, Declarant desires to expand the Project to include said additional phases. Upon recordation of this Amendment in the Davis County Recorder's office, the additional phases shall be subject to the Declaration.
- 2. Exhibit A; Property Description and Parcel Numbers. Following recordation of the Declaration, each phase of the Project was recorded in the Davis County Recorder's office and thereafter was assigned individual parcel numbers. As a result of the individual parcel numbers for the Lots, Declarant desires to supplement Exhibit A of the Declaration with Exhibit A-2, attached hereto and incorporated herein by this reference. For the avoidance of doubt, all parcel numbers listed on Exhibit A-2 shall be subject to and encumbered by the Declaration, as the same may be amended.
- 3. <u>Capitalized Terms</u>. Capitalized terms used, but not otherwise defined herein, shall have the meaning and definition given to such terms in the Declaration.
- 4. <u>Conflicts</u>. All remaining provisions of the Declaration and any prior amendments not specifically amended in this Amendment shall remain in full force and effect. In the case of any conflict between the provisions of. This document and the provisions of the Declaration or any prior amendments, the provisions of this Amendment shall in all respects govern and control.
- 5. <u>Incorporation and Supplementation of Declaration</u>. This Amendment is supplemental to the Declaration, which by reference is made a part hereof, and all the terms, definitions, covenants, conditions, restrictions, and provisions thereof, unless specifically modified herein, are to apply to this Amendment and are made a part hereof as though they were expressly rewritten, incorporated, and included herein.
