#### RECIPROCAL PARKING STRUCTURE DRAINAGE AGREEMENT

All maintenance must be scheduled with Charlie Chow to ensure maintenance does not hinder business operations.

The cost of the maintenance and necessary repairs of drainage facilities shall be shared between Oasis Games its successors or assigns and Charlie Chow its successors or assigns by the ratio of 68/32 (68% to Oasis Games its successors or assigns and 32% to Charlie Chow its successors or assigns). Both Charlie Chow and Oasis Games acknowledges and agrees to the right to enter the entire parking lot to maintain and operate the drainage facilities.
