AN ORDINANCE VACATING A
PORTION OF CONCORD STREET NORTH
OF 2ND SOUTH STREET IN SALT LAKE
CITY, UTAH.
BE IT ORDAINED BY THE BOARD
OF COMMISSIONERS OF SALT LAKE CITY,
UTAH: That a portion of
SECTION 1 That a portion of
CONCORD STREET NORTH OF 2ND SOUTH
STREET IN SALT LAKE CITY, UTAH, more
particularly described as follows:
Beginning at the northwest
corner of Lot 36, Block 5, High-
land Park Addition, a subdivision
of parts of Sections 2 and 3, T.
1 S., R. 1 W., S. 1 B. & M.;
thence north east 80 feet to
the northwest corner of Lot 21,
Block 4, said subdivision; thence
south 50 feet to the southwest
corner of Lot 22, said Block 4;
thence west 50 feet to the south-
east corner of Lot 35, said Block
5; thence north 50 feet to the
point of beginning.
BE AND THE SAME IS HEREBY VACATED
AND REOPENED TO BE USED AS A STREET, AVENUE,
ALLEY OR PEDESTRIAN WAY.
Said vacation is made expressly
subject to all existing rights of
way and easements of all public
utilities of any and every descrip-
tion now located in, on, under or
over the corners of the above de-
scribed property and also subject
to the right of entry thereon for the
purpose of inspecting, maintaining,
repairing, replacing, removing and
replacing of reticulating said utilities and
SECTION 2. In the opinion of
the Board of Commissioners, it is
necessary to the peace, health and
safety of the inhabitants of Salt
Lake County that the ordinance shall
become effective immediately.
SECTION 3. This ordinance shall
take effect upon its first publica-
tion.
