**AMENDMENT TO FIRST AMENDED DECLARATION OF CONDOMINIUM
FOR PINEBROOK COTTAGES CONDOMINIUM**

This Amendment To First Amended Declaration of Condominium for Pinebrook Cottages Condominium is made and executed by Pinebrook Cottages Homeowners Association of P. O. Box 980845, Park City, UT 84098-0845 (the "Association").

RECITALS

A. The First Amended Declaration of Condominium for Pinebrook Cottages Condominium was recorded in the office of the County Recorder of Summit County, Utah on July 10, 1995 as Entry No. 433075 in Book 893 at Pages 722-751 of the official records (the "Declaration").

B. The Association is the managing agent for all of the Unit Owners at the Pinebrook Cottages Condominium.

C. This document affects the real property located in Summit County, Utah, described with particularity on Exhibit "A," attached hereto and incorporated herein by this reference (the "Property").

D. The Property is subject to the Declaration.

E. The Unit Owners at Pinebrook Cottages Condominium desire to amend the Declaration in the manner set forth below.

F. All of the voting requirements of Article VIII, Section 8 of the Declaration have been satisfied. A copy of the vote tally sheet is attached hereto, marked Exhibit "B" and incorporated herein by this reference.

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Property and the owners thereof, the Successor Declarant hereby executes this Amendment To First Amended Declaration of Condominium for Pinebrook Cottages Condominium.

Article V of the Declaration is hereby amended to add the following new subsection:

5.27 Home Business. Anything to the contrary notwithstanding, no resident may operate a commercial trade or business in or from his or her unit without written consent from the Board of Directors and the business must satisfy the Home Occupation Guidelines adopted by the Board of Directors.

2. Article IV, Section 4.2 is hereby amended to add the following provisions:

The Board of Directors shall have the right, power and authority to adopt, amend and/or repeal rules and regulations for the governing of the Property, and to issue fines and sanctions for non-compliance of the governing documents, and establish a fine schedule.

3. In the event of any conflict, incongruity or inconsistency between the provisions of the Declaration and this Amendment, the latter shall in all respects govern and control.

4. The effective date of this Amendment is the date it is recorded in the office of the County Recorder of Summit County, Utah.
