AN ORDINANCE, AMENDING TITLE 19, ENTITLED "ZONING" OF THE SALT LAKE COUNTY CODE OF ORDINANCES, 1986, BY RECLASSIFYING CERTAIN PROPERTY LOCATED IN SALT LAKE COUNTY FROM A-1 TO C-2/ZC ZONE.

The Board of County Commissioners of Salt Lake County, State of Utah, ordains as follows:

Section 1: Section 19.06.020, The Zoning Map of Salt Lake County, Code of Ordinances 1986, is hereby amended, as follows:

The property described in Application PL-94-4064, filed by Irv Fisher & David Dean, and located within Salt Lake County, is hereby reclassified from A-1 to C-2/zc Zone, said property being described as follows:

BEGINNING AT A POINT WHICH IS N 0°02'55"W, ALONG THE SECTION LINE 1324.76 FEET AND WEST 903.16 FEET FROM THE SOUTH QUARTER CORNER OF SECTION 15, TOWNSHIP 2 SOUTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN; AND RUNNING THENCE NORTH 130.00 FEET; THENCE EAST 110.16 FEET; THENCE SOUTH 80.00 FEET; THENCE EAST 240.00 FEET; THENCE SOUTH 50.00 FEET; THENCE EAST 320.00 FEET; THENCE S 0°02'55"E, 128.30 FEET; THENCE EAST 50.00 FEET; THENCE N 0°02'55"E, 128.30 FEET; THENCE NORTHWESTERLY 184.81 FEET ALONG THE ARC OF A 158.22 FOOT RADIUS CURVE TO THE LEFT (CHORD BEARS N 33°30'38"W, 174.48 FEET) THENCE NORTH 20.00 FEET; THENCE N 73°29'01"W, 113.105 FEET; THENCE NORTHWESTERLY 335.215 FEET ALONG THE ARC OF A 1024.93 FOOT RADIUS CURVE TO THE RIGHT (CHORD BEARS N 62°55'04"W, 333.730 FEET); THENCE N 55°02'48"W, 483.78 FEET; THENCE SOUTH 648.22 FEET; THENCE EAST 185.28 FEET; THENCE N 18°05'00"W, 22.60 FEET TO THE POINT OF BEGINNING

Pursuant to Section 19.90.060 of the Salt Lake county, Code of Ordinances, 1986, development of property is subject to the following conditions:

The property is restricted to the following uses:

1. Neighborhood storage
2. Office, business or professional, office supply, office machines sales & repair
3. Open storage for recreational vehicles only
4. Mini-storage units, secondary to a main use of the parcel
5. Public & quasi-public use
6. Temporary buildings, etc.
7. All signs require conditional use approval

Section 2: The map showing such change shall be filed with the Salt Lake County Planning Commission in accordance with Section 19.06.020 of the Salt Lake County, Code of Ordinances, 1986.

Section 3: This ordinance shall take effect fifteen (15) days after its passage and upon at least one publication in a newspaper published in and having general circulation in Salt Lake County, and if not so published within fifteen (15) days then it shall take effect immediately upon its first publication.


