AN ORDINANCE

AN ORDINANCE VACATING Official Map No. 2, adopted by adding to Chapter LXV of the Revised Ordinances of Salt Lake City, Utah, 1944, a section known as Section 6738, relating to Official Street Map.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That that certain official street map known as "Official Map of Salt Lake City No. 2," approved, accepted and adopted August 14, 1951, by the Board of Commissioners of Salt Lake City, Utah, as an official map of Salt Lake City by that certain ordinance known as Section 6738, added to Chapter LXV of the Revised Ordinances of Salt Lake City, Utah, 1944, relating to zoning, being Bill No. 61 of 1951, published August 17, 1951, and heretofore recorded in the office of the County Recorder of Salt Lake County, Utah, be, and the same hereby is, vacated and set aside, and the City Recorder is directed to cause a copy of this ordinance to be recorded in the office of the County Recorder of Salt Lake County, Utah, and a copy hereof shall be placed on file in the office of the City Planning Engineer of Salt Lake City and henceforth building permits may be issued for construction as if said Official Map No. 2 had not been adopted.

SECTION 2. In the opinion of the Board of Commissioners, it is necessary to the peace, health and safety of the inhabitants of Salt Lake City that this ordinance become effective immediately.

SECTION 3. This ordinance shall take effect upon its first publication.
