CONVEYANCE OF EASEMENT
 FOR USE OF IRRIGATION DISTRIBUTION SYSTEM
 COTTONWOOD-GOOSEBERRY IRRIGATION COMPANY, a corporation organized
 and existing under the laws of the State of Utah, with its principal office at
 Fairview, Sanpete County, Utah, Grantor, hereby conveys and warrants to the
 State of Utah, acting through the BOARD OF WATER RESOURCES, Grantee, of
 Salt Lake City, Utah, for the sum of ten and no/100 dollars and other good and
 valuable consideration, receipt of which is hereby acknowledged, and for the
 consideration of an agreement dated June 28, 1967 with the State of Utah for the
 construction of a tunnel and appurtenant works, an easement to the use of the
 Grantor's water collection and water distribution systems including canals,
 ditches, lakes, tunnel and water conveyance structures, beginning at Boulger
 Creek and Gooseberry Creek, feeder canals to Fairview Lakes, and extending
 through the system to the irrigated land. Said system is situated in Sections
 6 and 7, T14S, R6E; Section 1, T14S, R5E; Section 31, T13S, R6E; Sections 36,
 35, 25, 24, 23, 30, 31, T13S, R5E; Sections 1, 12, 25, 36, T13S, R4E; Sections
 2, 11, 14, T14S, R4E; Sections 6 and 7, T14S, R5E, SLB&M.
