A RIGHT OF WAY 20 FEET IN WIDTH, BEING 10 FEET ON EITHER SIDE OF A CENTERLINE ACROSS THE NORTHEAST QUARTER OF SECTION 30, AND THE NORTHWEST QUARTER OF SECTION 29, TOWNSHIP 5 NORTH, RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY, MORGAN COUNTY, UTAH, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE WEST QUARTER CORNER OF SAID SECTION 30; THENCE NORTH 86°29'41" EAST 4102.66 FEET TO THE SOUTHEAST CORNER OR LOT 7, PROPOSED FOX HOLLOW SUBDIVISION; THENCE NORTH 03°35'20" EAST 8.58 FEET TO THE TRUE POINT OF BEGINNING;

THENCE NORTH 86°40'29" EAST 192.02 FEET; THENCE NORTH 81°54'22" EAST 427.22 FEET; THENCE NORTH 89°41'22" EAST 317.24 FEET; THENCE NORTH 44°30'51" EAST 274.07 FEET; THENCE SOUTH 84°10'44" EAST 362.74 FEET; THENCE NORTH 67°26'49" EAST 197.63 FEET; THENCE NORTH 58°32'01" EAST 490.82 FEET; THENCE NORTH 48°42'31" EAST 496.42 FEET; THENCE NORTH 71°25'47" EAST 987.54 FEET TO THE CENTER OF A PROPOSED 250,000 GALLON WATER TANK, WHERE SURVEY ENDS. AND FROM WHICH THE NORTHWEST CORNER OF SAID SECTION 29, BEARS NORTH 62°22'45" WEST 2387.56 FEET;

THE ABOVE DESCRIBED RIGHT OF WAY IS 3747.70 FEET IN LENGTH AND CONTAINS 1.72 ACRES.

ALSO, A RIGHT OF WAY FOR THE 250,000 GALLON WATER TANK AND RELATED FACILITIES, SITUATE IN THE NORTHWEST QUARTER OF SECTION 29, TOWNSHIP 5 NORTH, RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY, MORGAN COUNTY, UTAH, BEING MORE PARTICULARLY DESCRIBED AS FOLLOW:

COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 29; THENCE SOUTH 63°30'38" EAST 2246.28 FEET TO THE NORTHWEST CORNER OF THE TANK SITE; THENCE NORTH 90°00'00" EAST 210.00 FEET; THENCE SOUTH 00°00'00" EAST 300.00 FEET; THENCE SOUTH 90°00'00" WEST 210.00 FEET; THENCE NORTH 00°00'00" EAST 300.00 FEET TO THE POINT OF BEGINNING.

THE TANK SITE CONTAINS 1.45 ACRES.
