

QUIT CLAIM DEED

HAROLD CHRISTENSEN and DOROTHY CHRISTENSEN, his wife, and RUSSELL CHRISTENSEN and LYNILE CHRISTENSEN, his wife, GRANTORS, hereby release, remise and quit claim to RUSSELL CHRISTENSEN and LYNILE CHRISTENSEN, husband and wife as joint tenants with full rights of survivorship and not as tenants in common, the following described real property situated in Wasatch County, State of Utah, to-wit:

All of Section 1, Township 3 South, Range 5 East, Salt Lake Meridian.

The East half of the Southeast quarter of Section 10, Township 3 South, Range 5 East, Salt Lake Meridian.

The North half; the Southeast quarter; the Northeast quarter of the Southwest quarter of Section 11, Township 3 South, Range 5 East, Salt Lake Meridian.

The South half of the Southwest quarter; the Northwest quarter of the Southwest quarter of Section 11, Township 3 South, Range 5 East, Salt Lake Meridian.

Lots 3 and 4 and the North half of Section 12, Township 3 South, Range 5 East, Salt Lake Meridian.

The Northwest Quarter; the West half of the Northeast quarter of Section 13, Township 3 South, Range 5 East, Salt Lake Meridian.

The North half; the Southwest quarter of Section 14, Township 3 South, Range 5 East, Salt Lake Meridian.

BEGINNING at the Northwest corner of the Northeast quarter of Section 22, Township 3 South, Range 5 East, Salt Lake Meridian; thence East 160 rods; thence South about 264 rods; thence N28°37'W to a point 40 rods South and 21.82 rods East from the Northwest corner of the Northeast quarter; thence West 21.82 rods; thence North 40 rods to the place of beginning.

The West half of Section 23, Township 3 South, Range 5 East, Salt Lake Meridian, except: 8 acres in the Southwest corner of said section.

and hereby release, remise and quit claim to HAROLD CHRISTENSEN and DOROTHY CHRISTENSEN, husband and wife, as joint tenants with full rights of survivorship and not as tenants in common, the following described real property situated in Wasatch County, State of Utah, to-wit:

Lots 1, 2, 3 and 4; the Southwest quarter; and the West half of the Southeast quarter of Section 13,

Township 3 South, Range 5 East, Salt Lake Meridian.

The Southeast quarter of Section 14, Township 3 South, Range 5 East, Salt Lake Meridian.

The Southwest quarter of the Southwest quarter of Section 17, Township 3 South, Range 6 East, Salt Lake Meridian.

Lots 1 and 2; the East half of the Northwest quarter of Section 18, Township 3 South, Range 6 East, Salt Lake Meridian.

Lots 3 and 4; the East half of the Southwest quarter; the West half of the Southeast quarter; the Southeast quarter of the Southeast quarter of Section 18, Township 3 South, Range 6 East of the Salt Lake Meridian.

The Northeast quarter of Section 19, Township 3 South, Range 6 East, Salt Lake Meridian.

The West half of the Northwest quarter of Section 20, Township 3 South, Range 6 East, Salt Lake Meridian.

The East half of section 23, Township 3 South, Range 5 East, Salt Lake Meridian.

All of Section 24, Township 3 South, Range 5 East, Salt Lake Meridian.

All of Section 25, Township 3 South, Range 5 East, Salt Lake Meridian.

BEGINNING about 32 rods East of the Northwest corner of the Northwest quarter of Section 26, Township 3 South, Range 5 East, Salt Lake Meridian; thence East 288 rods to the Northeast corner of said section; thence South 320 rods to the Southeast corner of said Section; thence West 200 rods; thence North 160 rods; thence N28°37'W to the beginning.

Lots 1 and 2; the North half of the Northeast quarter; the East half of the East half of the Northwest quarter; ALSO: Beginning at the Southwest corner of the Northwest quarter of Section 35, Township 3 South, Range 5 East, Salt Lake Meridian; thence North 18 rods; thence East 120 rods; thence South 18 rods; thence West 120 rods to the beginning.

TOGETHER with all improvements thereon and appurtenances thereunto belonging.

SUBJECT TO AND RESERVING to the Grantors all mineral and mineral rights together with rights of ingress and egress for the purpose of exploration and development of the same in the following shares: An undivided one-half interest in and to said mineral rights to Harold Christensen and Dorothy Christensen, husband and wife, as joint tenants with full rights of survivorship and not as tenants in common, and an undivided one-half interest to Russell Christensen and Lynile Christensen, husband and wife, as joint tenants with full rights of survivorship and not as tenants in common.

Subject to and reserving to each Grantor joint use of all trailing rights

appurtenant to the properties.

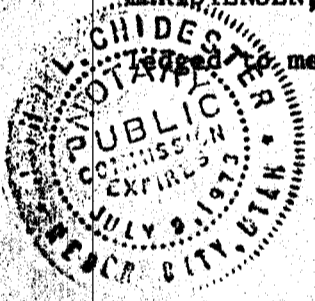
