BOUNDARY LINE AGREEMENT

THIS BOUNDARY LINE AGREEMENT (this "Agreement"), is made and entered into as of the signature date written below by AJ FIRESIDE PARK CITY LLC, a Delaware limited liability company ("Owner"), whose address is stated above, as the owner of the Parcels [defined below] in their existing configuration, and as the owner of the Parcels in their after-adjusted configuration, as described herein.

RECITALS


