THIS ASSIGNMENT is effective as of the 14th day of February 1991 and is entered by and between Wyoming-California Pipeline Company ("WyCal"), a Colorado General Partnership, P. O. Box 1087, Colorado Springs, Colorado 80944, and Kern River Gas Transmission Company ("Kern River"), a Texas General Partnership, P. O. Box 58900, Salt Lake City, Utah 84158-0900.

WHEREAS, WyCal is the grantee under the terms of various Right-of-Way, Easement and Damage Release Agreements covering lands located in the States of Utah and Wyoming which Agreements are described on Exhibit A attached hereto and by this reference made a part hereof (hereinafter collectively referred to as the "Agreements");

WHEREAS, Kern River desires to acquire all the right, title and interest which WyCal now owns under the terms of the Agreements.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to conditions hereinafter set forth, WyCal does hereby assign unto Kern River, its successors and assigns, all of WyCal's right, title and interest in and to the Agreements.

1. No Warranty By WyCal. This Assignment is made by WyCal to Kern River WITHOUT WARRANTY OF TITLE, EITHER EXPRESS OR IMPLIED, OF ANY KIND; except that WyCal warrants that there are no burdens, encumbrances or liens created by WyCal on the property and that WyCal has not previously released or conveyed the property to any other person.

2. Assumption of Obligations and Indemnification. Kern River hereby accepts the terms of the Agreements. Furthermore, Kern River hereby agrees to indemnify and hold harmless WyCal and its affiliates, and their officers, directors, employees, attorneys and agents from any and all losses, liabilities, liens, encumbrances, damages, judgments, demands, suits, claims, assessments, charges, fines, penalties or expenses (including but not limited to attorney fees, other costs of litigation, liability for environmental harm or damages to natural resources, and costs of complying with orders or directives of government entities and agencies) of any kind or character arising out of, in connection with, or resulting from the ownership, possession, operation, use or maintenance of the property covered by the Agreements, on or after the effective date of this Assignment.

3. Binding Effect. The terms and conditions of this Assignment shall be binding on and shall inure to the benefit of WyCal and Kern River, their successors and assigns.

WHEREFORE, WyCal and Kern River have executed this Assignment effective as of the date and year first above written.
