The Undersigned Grantor (and each and all of them if more than one) for and in valuable consideration hereby grant and convey to U S WEST COMMUNICATIONS, INC., a Colorado corporation, (Grantee) whose address is 250 Bell Plaza, #1110-A, Salt Lake City, Utah, 84111, its successors, and assigns, lessees, licensees and agents a perpetual easement to construct, reconstruct, operate, maintain, and remove, such telecommunications facilities as Grantee may require upon, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to wit:

A strip 5 feet in width being 2 1/2 feet on each side of the following described centerline:

Beginning at a point in the North line of a street, said point being 782.97 feet South and 66.87 feet West and North 86 degrees 24 East 7 feet from the West Quarter Corner of Section 28, Township 1 South, Range 1 East, Salt Lake Ease and Meridian, thence North 90 feet to end,
