THE UNITED STATES OF AMERICA CERTIFICATE NO. 2572.

TO ALL TO VHOLITHESE PRESENTS SHALL COME GREETING: Whereas Alfred G. Wilson, of Emery County, Utah Territory, has deposited in the General Land Office of the United States a certificate of the Register of the Land Office at Salt Lake Chty, Utah Territory, whereby it appears that all payment has been made by the said Alfred G. Wilson according to the provisions of the act of Congress of the 24thdday of April, 1820, entitled. "An Act making further provision for the sale of the public Lands," and the acts supplemental thereto, for the South Half of the North West quarter and the Lots numbered three and four of Section one in township Twenty six Nouth, of Range Twanty One East of the Salt Lake Meridian in Utah Territory containing one hundred and sixty actes. According to the Official plat of the Survey of the said Lands, returned to the General Land Office by the surveyor general, which said tract has been purchased by the said Alfred C. Vilson.

Now Ye, that the United States of America, in consideration of the premises, and in conformity with the several acts of Congress in such case made and provided, have given and granted, and by these presents do give and grant, unto the soid Alfred G. Wilson and to his heirs the said tract above described; To have and to hold the same together with all the rights, privaleges, immunities and appurtenances, of whotsoever nature therature belonging, unto the said Alfred C. Wilson and to his heirs and assigns forever, subject to any vested and accrued water rights for mining, aggricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognised and acknowledged by the local customs, laws, and decisions of courts and also subject to the rights of the proprietor of a vein or lade to extract and remove his one therefrom, should the same be found to penetrate or intersect the premises hereby granted as provided by law,

In testamony whereof, I, Grover Cleweland, president of the United States of America, have caused these letters to be made ratent and the seal of the General Land Office to be hereunto affixed,

Given under my hand, at the City of Washington, the Seventhenth day of March, in the year of our Lord one thousand eight hundred and eighty seven, and of the Independence of the United States the one hundred and eleventh.
