# QUIT-CLAIM DEED

D. H. SHIELDS and LENA SHIELDS, husband and wife

of Moab, County of Grand, State of Utah, hereby grantor  
QUIT-CLAIM to

CITY OF MOAB, a body corporate and politic of the State of Utah

of One and other good and sufficient grantee for the sum of DOLLARS,

the following described tract of land in Grand County, State of Utah:

A strip of land one hundred feet (100.0') in width - fifty (50.0') feet on each side of a centerline which is described as follows: Beginning at a point from whence the Official Intersection Monument at the intersections of the centerlines of Center street and 100 West Street, Moab Township, Grand County, Utah, lies S 00°-17' W 355.1 feet; and from whence the North Quarter Corner of Section 1, Township 26 South, Range 21 East, Salt Lake Base and Meridian, Grand County, State of Utah; bears N 6°-39' E 1873.7 feet, thence running N 88°-04' W a distance of 497.3 feet to the P.C. of a curve to the left; thence running around the arc of 0°-50.8' curve to the left a distance of 399.8 feet (Radius = 6,770.5 feet, I = 3°-23' L) whose chgd bears N 89°-45.5' W a distance of 399.8 feet to the point of tangency of the curve, thence S 88°-33' W a distance of 1523.7 feet to a point on the Section Line between Section 1 and Section 2, Township 26 South, Range 21 East, Salt Lake Base and Meridian and which point lies S 00°-11' W a distance of 1873.8 feet from the Northwest Corner of Section 1, Township 26 South, Range 21 East, Salt Lake Base and Meridian.
