EASEMENT

47. HARRY G. WRIGHT and AILEEN G. WRIGHT, his wife, Grantor S, do _____ hereby convey and warrant to PacifiCorp, an Oregon corporation, dba Utah Power & Light Company, whose principal place of business is located at 1407 West North Temple, Salt Lake City, Utah, its successors in interest and assigns, Grantee, for the sum of Ten (\$10.00) Dollars and other valuable consideration, a perpetual easement and right of way for the erection, operation, maintenance, repair, alteration, enlargement, inspection, relocation and replacement of electric transmission and distribution lines, communications circuits, fiber optic cables and associated facilities, and eleven (11) poles and two (2) guy anchors, with the necessary guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said lines and circuits, on, over, under and across real property located in Tooele County, Utah, described as follows:

A right of way 25 feet in width, being 12.5 feet on each side of the following described survey line:

Beginning on line (2-3) of Plomo No. 11 Mining Claim, Survey No. 5072 at a point S.87°53'E. 2 feet, more or less, from Corner No. 2 of said mining claim, said point also being 1025 feet north and 510 feet west, more or less, from the south one quarter corner of Section 7, T. 4S., R. 4W., S.L.M., thence S.26°52'W. 160 feet, more or less, thence S.36°09'W. 3142 feet, more or less, to a point 125 feet north and 145 feet east, more or less, from Corner No. 4, Plomo #5 Mining Claim, Survey No. 5072 and being in the following mining claims; Plomo No. 5, 6, 8, 9, 10 and 11, Survey No. 5072, Rush Valley Mining District in the SE¼ of the SW¼ of said Section 7, and the N¼ of the NW¼ and the SW¼ of the NW¼ of Section 18,

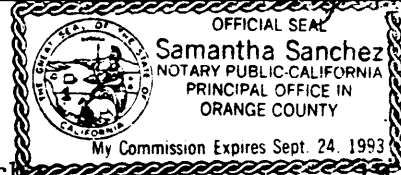
