## AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR UFFENS MARKETPLACE CONDOMINIUMS

A UTAH MIXED USE CONDOMINIUM PROJECT

## **RECITALS**

- A. Certain real property in Salt Lake County, Utah, known as Uffens Marketplace Condominiums was subjected to certain covenants, conditions and restrictions pursuant to a Declaration of Condominium recorded June 20, 2003, as Entry No. 8698715 in the Recorder's Office for Salt Lake County, Utah (the "Declaration").
- B. This amendment shall be binding against the property described in the Declaration and any annexation or supplement thereto, as described in **Exhibit "A."**
- C. The Uffens Marketplace Unit Owners Association (the "Association") has determined that basing the method of allocation of common expenses on the square footage of a unit has not turned out to be a fair method because smaller commercial units with high customer traffic have placed as much of a burden on the Association as much larger commercial units and the Association has determined that one rate for all commercial units and one rate for residential units is the most fair method of allocating responsibility for the common expenses of the Association and that the percentages of Owners' undivided interests in the common area should be changed accordingly.
- D. Pursuant to the Utah Condominium Ownership Act, specifically, U.C.A. § 57-8-7(3), and the Declaration, the undersigned hereby certifies that all of the voting requirements to amend the Declaration have been satisfied and that the affirmative vote of at least two-thirds of the Owners and 51% of the Eligible Mortgagees has been obtained to adopt this Amendment.
- NOW, THEREFORE, the Association hereby amends the first sentence, and only the first sentence, in Article 3, Section 3.3 of the Declaration by deleting the only comma in the sentence and every word in the sentence after the comma. The deleted language is shown in strikethrough format as follows:
- 3.3. Nature of Undivided Interests. Each Unit Owner shall be entitled to an Undivided Interest in the percentage expressed in the attached exhibit A, which interests are allocated proportionate to the size of each Unit. (Remainder of Section 3.3 to remain the same).

NOW, THEREFORE, the Association hereby amends the table in Exhibit A to the Declaration of Condominium and Bylaws by replacing it with the following table:
