The Northwest quarter (NW $\frac{1}{4}$ ) of the Northwest quarter (NW $\frac{1}{4}$ ); the East Half (E $\frac{1}{2}$ ) of the Northwest quarter (NW $\frac{1}{4}$ ) and the Northeast quarter (NE $\frac{1}{4}$ ) of Section Twenty-Three (23) in Township Two (2) South Range Five (5) East of the Salt Lake Meridian, containing Two Hundred and Eighty (280) acres according to the said certificate.

TO HAVE AND TO HOLD the above described and granted premises unto the said Isaac M.
