

POLE LINE EASEMENT

David D. Hooper and Alice Hooper  
his wife, Grantor.s, of Weber County, Utah, hereby convey and warrant  
to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns,  
Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement  
and right of way for the erection and continued maintenance, repair, alteration, and replacement  
of the electric transmission, distribution and telephone circuits of the Grantee, and  
no guy anchors and one pole, with the necessary guys, stubs, crossarms and  
other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and  
maintained upon and across the premises of the Grantor.s, in Weber County,  
Utah, along a line described as follows:

Beginning at the south boundary line of the Grantors' land at a point 915 feet  
east, more or less, from the southwest corner of Section 30, T. 6 N., R. 1 W.,  
S.L.M., thence N. 7° 18' W. 70 feet, more or less, to the west boundary fence of  
said land and being in the SW 1/4 of the SW 1/4 of said Section 30.

Also, beginning at the southwesterly boundary line of the Grantors' land at  
a point 260 feet north and 878 feet east, more or less, from the southwest corner of  
Section 30, T. 6 N., R. 1 W., S.L.M., thence N. 7° 18' W. 25 feet, more or less,  
to the northeasterly boundary fence of said land and being in the SW 1/4 of the  
SW 1/4 of said Section 30.

Together with all rights of ingress and egress necessary or convenient for the full and complete  
use, occupation and enjoyment of the easement hereby granted, and all rights and privileges  
incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches  
and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment  
of this easement.
