EASEMENT AGREEMENT

THIS EASEMENT AGREEMENT ("**Agreement**") is made to be effective as of the 19 day of September, 2007 by and between SOUTH JORDAN REAL ESTATE, L.C., a Utah limited liability company ("**SJRE**") and HARVEST VILLAGE CORP., a Utah corporation ("**Harvest Village**").

WHEREAS, SJRE is the fee owner of Lot 3, Harvest Village at South Jordan Subdivision Phase I situated in the City of South Jordan, County of Salt Lake, State of Utah (the "**SJRE Parcel**"); and

WHEREAS, Harvest Village is the fee owner of certain real property described as:

Lot 4, Harvest Village at South Jordan Subdivision Phase I according to the plat thereof as recorded in the Official Records of Salt Lake County, Utah.

situated in the City of South Jordan, County of Salt Lake, State of Utah (the "**Harvest Village Parcel**") which is adjacent to the SJRE Parcel; and

WHEREAS, Harvest Village has agreed, subject to the covenants, conditions and restrictions set forth herein, to grant SJRE a non-exclusive right of ingress and egress for vehicular and pedestrian traffic over the Harvest Village Parcel for purposes of accessing River Heights Drive and 10400 South Jordan Parkway from the SJRE Parcel,

NOW, THEREFORE, the parties agree as follows:

1. Creation of Easement. Harvest Village hereby grants and establishes for the benefit of SJRE, its assigns and successors, members, customers and employees, a non-exclusive right of ingress and egress for pedestrian and vehicular traffic over and across a portion of the Harvest Village Parcel, as more particularly shown on attached Exhibit "A" (the "**Easement Area**").

2. Use of Easement Area.

(a) Use. Subject to existing easements of record, SJRE and its customers, invitees and employees may use the Easement Area for ingress, egress and walkways.

(b) No Barriers. Neither party shall construct or maintain any wall, fence or barrier of any kind on the Easement Area which prevents or impairs the use, free access or movement over or across the Easement Area, including without limitation, pedestrian and vehicular traffic.

3. Maintenance. Harvest Village shall be responsible for all repairs and maintenance relating to the Easement Area, provided however, that SJRE shall pay its pro-rata share of the costs of such repairs and maintenance. The pro-rata share shall be determined based upon the size of the SJRE Parcel in relation to the total size of all parcels owned by other parties which have been granted a non-exclusive right of ingress and egress for pedestrian and vehicular traffic over the Easement Area.

4. Not a Public Dedication. Nothing contained herein shall be deemed to be a gift or dedication of any portion of the Easement Area to the general public, for the general public or for any public purpose whatsoever. The right of the public or any person to make any use whatsoever of the Easement Area is by permission and subject to Harvest Village's control. Notwithstanding any other provisions herein to the contrary, Harvest Village may periodically restrict ingress and egress from the Easement Area in order to prevent a prescriptive easement from arising by reason of continued public use. Any restriction on ingress and egress shall be agreed to by the parties in writing prior to such restriction, shall be limited to the minimum period necessary to prevent the creation of a prescriptive easement and shall occur at such time as to have a minimal effect on the parties.

5. Miscellaneous.

(a) Covenants Running with the Land. This Agreement and all of the terms and conditions contained herein shall inure to the benefit of, and shall be binding upon the parties hereto and their respective successors and assigns, and shall be "covenants running with the land".

(b) No Waiver. A delay in enforcing or a failure to enforce any breach or violation of any restriction herein contained shall not be deemed to be a waiver or abandonment of any such restriction, or a waiver of the right to enforce any subsequent breach or violation of such restriction. The foregoing shall apply regardless of whether any person affected hereby (or having the right to enforce these restrictions) had knowledge of the breach or violation.

(c) Severability. If any one or more of the provisions of this Agreement or the applicability of any such provision to a specific situation shall be held invalid or unenforceable by a court of competent jurisdiction, the validity and enforceability of all the provisions of this Agreement and all other applications of such provisions shall not be affected thereby.

(d) Governing Law. This Agreement shall be construed and enforced in accordance with the laws of the State of Utah.

(e) Successors. This Agreement shall be binding upon the heirs, successors and assigns of the parties.

(f) Attorneys' Fees. If any legal action or other proceeding is brought for the enforcement of this Agreement, or because of an alleged dispute, breach, default, or misrepresentation in connection with any of the provisions of this Agreement, the successful or

prevailing party shall be entitled to recover reasonable attorneys' fees and other costs incurred in that action or proceeding, in addition to any other relief to which it or they may be entitled.

(g) Recording. This document shall be recorded in the Official Records of Salt Lake County, Utah.


(h) Amendment. This Agreement may only be amended in a writing executed by both parties.

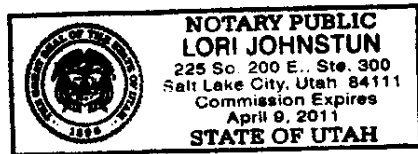

WHEREAS, Harvest Village is the fee owner of certain real property described as:

Lot 4, Harvest Village at South Jordan Subdivision Phase I, according to the official plat thereof, as recorded in the office of Salt Lake County Recorder.

The right of the public or any person to make any use whatsoever of the Easement Area is by permission and subject to Harvest Village's control. Notwithstanding any other provisions herein to the contrary, Harvest Village may periodically restrict ingress and egress from the Easement Area in order to prevent a prescriptive easement from arising by reason of continued public use. Any restriction on ingress and egress shall be agreed to by the parties in writing prior to such restriction, shall be limited to the minimum period necessary to prevent the creation of a prescriptive easement and shall occur at such time as to have a minimal effect on the parties.

If any legal action or other proceeding is brought for the enforcement of this Agreement, or because of an alleged dispute, breach, default, or misrepresentation in connection with any of the provisions of this Agreement, the successful or prevailing party shall be entitled to recover reasonable attorneys' fees and other costs incurred in that action or proceeding, in addition to any other relief to which it or they may be entitled.


(g) Recording. This document shall be recorded in the Official Records of Salt Lake County, Utah.

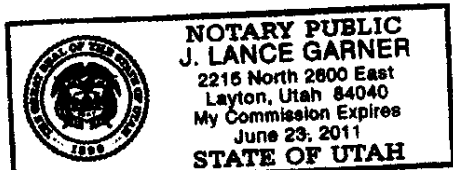
