**THIS AGREEMENT**, made and entered into this 13<sup>th</sup> day of August, A.D. 2008,  
by and between the UTAH DEPARTMENT OF TRANSPORTATION, at 4501 South 2700 West,  
Salt Lake City, Utah 84119, First Party, and NIMBUS PROPERTIES, L.C., a limited  
liability company, of OREM, County of UTAH, State of UTAH,

### WITNESSETH:

**WHEREAS**, a certain tract of real property, situate in the NE ¼ of the NE ¼ of Section  
22, T. 5 S., R. 1 E., S.L.B.&M., in Utah County, State of Utah, adjoins the Southerly right  
of way and limited-access line of the existing controlled-access State Route 145, and has certain  
rights of access to or from said highway over and across said right of way and limited-access line for  
One 20 -foot opening centered at a point opposite Highway Engineer Station 23+00, and;

**WHEREAS**, both parties desire to increase the size of and/or change the location of the  
hereinabove described access opening to a more desirable size and/or location.

**NOW THEREFORE**, for the consideration of the mutual benefit of the parties hereto and  
for other good and valuable consideration, the sufficiency of which is acknowledged, it is agreed by  
and between the parties hereto that the hereinabove described access opening is hereby released and  
relinquished and shall be forever closed to the Second Party, their heirs, successors or assigns; and in  
exchange for said closing, the First Party grants to the Second Party, their heirs, successors or  
assigns, the right of access to the nearest roadway of said highway over and across the Southerly  
right of way and limited-access line for One 46 -foot commercial access opening, which said  
opening centers at a point directly opposite Highway Engineer Station 22+00.

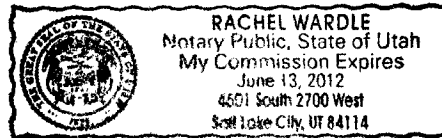
