EASEMENT AGREEMENT

This Easement Agreement is entered into this 27th day of FEBRUAL, 2003, by and between DANSIE FAMILY TRUST ("Grantor") and PacifiCorp, an Oregon corporation, d.b.a. Utah Power & Light Company ("Grantee").

RECITALS

- A. On the 10th day of August, 1987, Vilate F. Dansie (the "Original Grantor") conveyed that certain easement and right-of-way (the "Original Easement") Utah Power & Light Company recorded on 21st day of August, 1987, with the Utah County Recorder's Office at Entry No. 32023, Book 2444, Page 429.
 - B. Grantor is the successor in interest to the Original Grantor.
 - C. Grantee is the successor in interest to Utah Power & Light Company by Merger.
- D. Under the terms of the Original Easement, Grantee acquired the right to locate up to three (3) power poles and three (3) guy anchors within Grantor's land in with the boundaries of the Original Easement as more particularly described as follows:

A right of way 40 feet in width being 20 feet on each side of the following described survey line:

Beginning at the north boundary fence of the Grantor's land, said north boundary fence also being the south right of way fence of 7350 North Street, at a point 987 feet north and 253 feet east, more or less, from the southwest corner of Section 19, T.5 S., R.1 E., S.L.M., thence S.0°51' W. 986.4 feet, thence S.89°50' W. 1.5 feet to the south boundary fence of said land and being in Lot 4 of said Section 19; containing 0.91 of an acre, more or less.

E. PacifiCorp desires to install one (1) additional power pole within the easement and right-of-way to which Grantor has given consent under the terms and conditions expressed herein.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby accepted and received, the parties hereto agree to amend the 1987 Easement as follows:

1. Grantee shall have the right to install up to four (4) power poles within the easement described above, without any additional guys and anchors.

2.	All of the rights, privileges, and incidents of ownership set forth in the Original Easement shall
continue in full fo	orce and effect and with the exception of the modification to allow the installation of an
additional faciliti	es as set forth herein, the Original Easement shall not be deemed to be have been amended in
any other way.
