Beginning at a fence on the quarter section line at a point 24 feet north, more or less, from the south quarter corner of Section 7, T. 3 S., R. 5 W., S. L. M. thence N. 89° 14' E. 2635 feet to a fence on the section line and being in the S 1/2 of the SE 1/4 of said Section 7.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
