THOS. SCHOTT, Grantor of Provo, County of Utah, State of Utah, hereby license and permit
the State Road Commission of Utah, Licensee, for the sum of Thirty and 00/100 Dollars to use
the following described premises situated upon the grantor land in Lots 7 and 8, Block 1, Bay
View City Plat "H", in Utah County, Utah, for the purpose of constructing thereon an irrigation
ditch and appurtenant parts thereof:

A strip of land 10 feet wide along the easterly end of Lots 7 and 8, Block 1, Bay View
City Plat "H", a subdivision of the west 1/2 of Section 17, T. 7 S., R. 3 E., S. L. B. & M.,
said strip of land is parallel to and adjacent southwesterly to the southwesterly right of
way line of State Highway U. S. 91(F.A. Project No. 35-37).

Above described strip of land contains 0.012 acre.

After said irrigation ditch is constructed on above described premises at the expense
of Licensee, said Licensee is thereafter relieved of any further claim or demand for costs,
damages or maintenance charges which may accrue against said irrigation ditch or appurtenant
parts thereof.

RIGHT OF WAY DEED F.A.P. 167-B-23

LILLIAN M. MILLER grantor of Goshen, County of Utah State of Utah, hereby grants, bargains,
and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Two 40/100 DOLLARS,
the following described right of way across the grantor's land in Utah County, State of Utah,
as follows:

Right of way for highway known as F. A. Project No. 167-B across the grantor's land in the
NE 1/4 SW 1/4 of Section 7, T. 10 S., R. 1 E., S. L. M. Said right of way is contained within a
strip of land 100 ft. wide, 50 ft. on each side of the center line of survey of said project.
Said center line is described as follows:

Beginning at the intersection of the West boundary line of said grantor's land and said
center line of survey at Engineer's Station 698/08, which point is 2328.2 ft. S. 86° 14' W.,
and 1784.8 ft. S. 71° 00' W., along said center line of survey, from the East 1/4 corner of said
Section 7; thence N. 71° 00' E., 1456 ft. to the intersection of said center line of survey
at Engineer's Station 712/64 and the East boundary line of said grantor's land, which point
is 2328.2 ft. S. 86° 14' W, and 328.8 ft. S. 71° 00' W., along said center line of survey,
from said East 1/4 corner of Section 7, as shown on the official map of said project on file
in the office of the State Road Commission of Utah. Above described tract of land contains
3.34 acres, of which 2.94 acres are now occupied by the existing highway Balance 0.40 acre.

In executing this deed, the grantor hereby grants to the State Road Commission of Utah
permission to relocate and reconstruct within the grantor's land and outside the limits of above
described right of way, all irrigation ditches existing within said limits of above described
right of way.

The purpose of this deed is to grant a perpetual right of way for highway purposes.
