AN ORDINANCE GRANTING APPROVAL TO THE VACATION OF PLAT H, BAY VIEW CITY SUBDIVISION, LOCATED AT APPROXIMATELY 1640 TO 1900 SOUTH STATE STREET IN THE EXISTING A-1-5 (AGRICULTURAL ZONE), SPRING CREEK NEIGHBORHOOD, PROVO CITY.

WHEREAS, based on the recommendation of the Planning Commission, the Municipal Council finds that this plat amendment conforms to all zoning and subdivision regulations of Provo City;

WHEREAS, based on the recommendation of the Planning Commission, the Municipal Council finds none of the property owners in the Amended Plat will be materially damaged by the change in configuration of this plat;

WHEREAS, this matter is done in furtherance of the public's health, safety, morals, and general welfare;

WHEREAS, notice and public hearing has been held to ascertain the facts on this matter;

WHEREAS, pursuant to the recommendations and conditions proposed by the Planning Commission as presented to the Council, the Municipal Council finds that the final approval said Plat as described hereafter is in the furtherance of the health, safety and general welfare of the citizens of Provo City.

NOW, THEREFORE, be it ordained by the Municipal Council of Provo City, Utah, as follows:

PART I:

Approval of the vacation of Plat H, Bay View City Subdivision, located at approximately 1640 to 1900 South State Street, subject to the conditions established by the Planning Commission, as said Plat is more specifically defined in the attached map, in the A-1-5 zone, Spring Creek Neighborhood, Provo, Utah is in the furtherance of the health, safety and general welfare of the citizens of Provo City and is hereby granted.

PART II:

This ordinance shall take effect immediately after being posted or published as required by law.
