## QUIT CLAIM DEED

Commencing East 1351.3 feet and South 89 deg. 59'43" West 157.11 feet from the West 1/4 Corner of Section 17, Township 7 South, Range 3 East, Salt Lake Base and Meridian; and running thence South 3 deg. 10'0" West 93.56 feet; thence South 86 deg. 50'0" East 89.6 feet; thence South 32 deg. 32'0" East 94.89 feet; thence South 3 deg. 10'0" West 102.95 feet; thence South 86 deg. 50'0" East 73.97 feet; thence North 32 deg. 32'0" West 18.44 feet; thence South 86 deg. 50'0" East 140.36 feet; thence South 32 deg. 32'0" East 123.11 feet; thence North 86 deg. 50'0" West 140.34 feet; thence South 32 deg. 32'0" East 37.7 feet; thence South 57 deg. 28'0" West 10 feet; thence North 86 deg. 50'0" West 207.8 feet; thence South 2 deg. 37'52" West 243.7 feet; thence South 89 deg. 52'0" West 214.99 feet; thence North 38 deg. 13'0" West 818.48 feet; thence North 89 deg. 59'43" East 668.36 feet to the point of beginning.

This deed is not intended, and shall not be construed, to convey to grantee any interest in that water right denominated in the Office of the Utah State Engineer as water right number 55-1282 (a24387) which is a spring located on the grantee's property. The parties hereto specifically understand and agree that an application to change the point of diversion of this water right has been approved by the office of the Utah State Engineer. The approved change application authorizes a change of the point of diversion of said water right, from the grantee's property to the property of grantor.

Additionally, this deed is not intended and shall not be construed as conveying any interest of grantor in a subterranean water pipeline, or in an easement for maintence and access

to said pipeline, for the transmission of waters from Boardman Springs to grantor's property, all of which rights are specifically reserved unto grantor. The location of the subterranean water pipeline is described as follows:

Description of the Pacific States Cast Iron Pipe Company (PSCIPCo) "Boardman Springs" pipeline and ditch line:

Beginning at the center of a concrete box pipeline structure at the northwesterly corner of the intersection of South State Street (S.R. 89) and 1680 South Street. Provo, Utah, which beginning point lies North 89°37' 29" East along the Section line 1101.65 ft. and North 2986.76 ft. from the Southwest Corner of Section 17. Township 7 South. Range 3 East, Salt Lake Base and Meridian; thence along the center of an existing pipeline by the following eight (8) courses and distances: South 33 ° 18 '48" East 351.52 ft.; thence South 31 °37' 38" East 265.37 ft.; thence South 32 ° 56' 47" East 162.83 ft.; thence South 3 °47' 38" West 141.86 ft.; thence South 8 ° 17' 13" East 165.49 ft.; thence South 14°08' 30" East 130.50 ft.; thence South 13° 51' 21" East 198.51 ft.; thence South 47° 16' 47" West 197.54 ft.; thence leaving said pipeline, and continuing along the center of an open ditch by the following eight (8) courses and distances: South 2°36' 46" West 112.59 ft.; thence South 66°49' 06" West 63.14 ft.; thence South 68°44' 53" West 54.56 ft.; thence South 56° 12' 25" West .12.02 ft.; thence South 51 °48' 35" West 25.65 ft.; thence South 51 °28' 47" West 42.90 ft.; thence South 43 °38' 06" West 26.04 ft.; thence South 51 °31' 51" West 57.27 ft.

Grantee, at its sole expense, may relocate the pipeline and easement provided that the relocation does not reduce the rate of gravity flow or the efficiency of gravity flow of water in the pipeline. Any such changes shall be accomplished at a time and in a manner so as not to interfere with grantor's operations. Grantee shall notify grantor in writing at least thirty (30) days prior to any construction or excavation for the relocation of the pipeline.
