DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF CUSTOM INDUSTRIAL COMPLEX

AMENDMENT I

THIS DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF CUSTOM INDUSTRIAL COMPLEX, AMENDMENT I, a commercial condominium project, is executed this 30th day of July, 2018 by Brent Reichert, Byron Nickels or Larry Nickels, Jeff Gliattli and Filbert Archibeque, hereinafter "Board of Trustees."

By VOTE and ratification of the owners and Board of Trustees, on September 29, 2017, the following Amendments to the Declaration of Covenants, Conditions and Restrictions of Custom Industrial Complex, Inc. otherwise known as the Association, are as follows:

ARTICLE III. THE ASSOCIATION

5. Professional Management

The Professional Management allows assignment of an Owner Manager to engage strictly under the direction of the Board of Trustees, shall be responsible for managing the Project for the benefit of the Association and the Owners, and shall to the extent permitted by law and by the terms of the agreement with the Association, be authorized to perform any of the functions or acts required or permitted to be performed by the Association itself.

ARTICLE V. ASSESSMENTS

1. Agreement to Pay Assessments.

Sections A and B.

Cam fees increased from \$80.00 per month per unit due on the 1st of every month, to \$160.00 per month, per unit, due and owing on the 6th of every month. A late fee of 10% per annum will be assessed on the 7th day of each month, thereafter by the 21st day of the month, it there will be an additional 5% per annum assessed.

MEMORANDUM OF UNDERSTANDING

ARTICLE X. GENERAL USE RESTRICTIONS

12. Signs. The following rules shall apply to signs:

The only unit signage permitted shall be limited to the Owner's front door and adjacent window. Lettering shall not exceed six (6) inches in height.

On or about June 8, 2015, the Declarant, Robert Thatcher, did not object to the owner of Unit A-1, installing a sign on the upper exterior of their respective Unit, not to exceed 24" high and 36" wide, NO EXCEPTIONS, there must be a metal frame permanently mounted with replaceable glass or plastic insert that can be replaced with new if the condominium changes ownership. The metal base may not be removed once installed. The sign shall not be electrically lighted, neon or digital, banners, fabrics, painted letters or numbers on the side of the building.

Unit A-1, will be the only Unit permitted to have an exterior sign as described above. Removal of the permanent metal base could result in a fine of up to \$500 to repair and repaint the wall surface. The Board of Trustees has a right to pursue legal recourse with the fines and attorney fees if this memorandum of understanding is violated.

ALL LANGUAGE IN ARTICLES III, V AND X, THAT IS NOT EXCLUSIVELY AMENDED HEREIN, SHALL REMAIN IN FULL FORCE AND EFFECT.
