NOW THEREFORE, Beneficiary, in pursuance of the agreement and for good and valuable consideration, receipt of which is hereby acknowledged, does for himself his successors and assigns, hereby covenant, consent and agree to and with Lender, it's successors and assigns, that said Deed of Trust in favor of the Beneficary is and shall continue to be subject to and subordinate in lien to the lien of the Deed of Trust in favor of said Lender being recorded as Entry Number 246246 of Official Records of said County, on the above described of Official Records of said County, on the above described property.
