AMENDMENT TO ARTICLE 2.12 OF THE BYLAWS OF  
CONDOMINIUM FOREST GLEN HOMEOWNERS ASSOCIATION  
FOR  
PHASES I-VI

5-140

Bylaw 2.12 is amended to read:

2.12 Votes: Corporation's Acceptance of Votes. At all meetings of owners and for all actions by the owners i.e. (Board elections, Budget approval, amenities fees, assessments, etc.) an owner may cast one vote per unit, in person, by mail, or by proxy if the mailed ballot or proxy is received by the Secretary of the Corporation prior to the scheduled time of the meeting. Each secret ballot shall be prepared by a committee of volunteers at the Board of Director's request. This same committee may also be assigned by the Board of Directors to print the secret ballots and to mail them and to tabulate the voting results with a member of the Board present. The affirmative vote of a majority of the votes entitled to be cast by the members present (in person or by mail) or represented by proxy at a meeting at which a quorum was initially present shall be necessary for the adoption of any matter voted on by the members, unless a greater proportion is required by the Articles, these Bylaws, the Declaration, or the Act. When more than one Person owns an interest in a Unit, such persons shall designate to the Association, in writing, a representative who shall exercise the vote for such Unit on behalf of all co-owners of the Unit. In no event shall fractional votes be exercised in respect to any Unit.

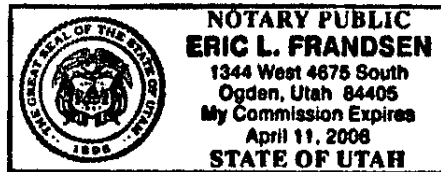
If the name signed on a vote, ballot, consent, waiver, or proxy appointment corresponds to the name of a member, the Corporation, if acting in good faith, is entitled to accept the vote, consent, waiver, or proxy appointment and give it effect as the act of the member. The Corporation is entitled to reject a vote, consent, waiver, or proxy appointment if the secretary or other officer or agent authorized to tabulate votes, acting in good faith, has reasonable basis for doubt about the validity of the signature on it or about the signatory's authority to sign for the member. The Corporation and its officer or agent who accepts or rejects a vote, consent, waiver, or proxy appointment in good faith and in accordance with the standards of this section are not liable in damages to the member for the consequences of the acceptance or rejection. Corporate action based on the acceptance or rejection of a vote, consent, waiver, or proxy appointment under this section is valid unless a court of competent jurisdiction determines otherwise.

The owners made their decision known by way of 96 affirmative consents in writing out of 136 possible.
