All of its right, title and interest in and to all lands acquired for, and all lands occupied by, and all lands used in connection with, the Provo Reservoir Canal (exclusive of laterals) from the diversion works of the said Canal on Provo River in the Southeast Quarter (SE_4^1) of Section Six (6), Township Six (6) South, Range Three (3) East, Salt Lake Meridian, and running thence to the mouth of Provo Canyon, and thence in a general Northwesterly direction to a point at or near the Jordan Narrows in the Southwest Quarter (SW_4^1) of Section Twenty-six (26), Township Four (4) South, Range One (1) West, Salt Lake Meridian, from which point the South quarter corner of Section Twenty-six (26), Township Four (4) South, Range One (1) West, Salt Lake Meridian, bears South 41°38' East Two Thousand Two Hundred Seventy-four (2,274.0) Feet, more or less.
