This relinquishment of use of the temporary right-of-way area shall not be construed to affect any of the rights of the United States under the Act of August 30, 1890 (26 Stat. 391).

Also, this relinquishment does not affect in any manner Parcel No. JA-467(F), described in the above-mentioned Contract, which is required by

A parcel of land in Utah County, Utah, in the North Half of the North Half  $(N_2^1N_2^1)$  of Section Thirty-three (33), Township Four (4) South, Range One (1) East, Salt Lake Meridian, Utah, containing Two and Thirteen-hundredths (2.13) acres, more or less, and being more particularly described as follows:

Bearings in the following description are based on the Utah Coordinate System, Central Zone.

Beginning at a point which lies South 00°05' East, Twelve Hundred Fifty-one and Eight-tenths (1251.8) feet along the Section line and North 89°55' East, Twenty-nine Hundred Eighty-six (2986.0) feet from the Northeast corner of said Section Thirty-three (33); said point has U.S.C. & G.S. plane grid coordinates North 764,555.49 and East 1,905,835.34; thence South 89°42' West, Two Hundred Seventy-three and Two-tenths (273.2) feet to point of a regular curve to the right; thence along the arc of said curve having a 5,790-foot radius Eight Hundred Ninety-one and Two-tenths (891.2) feet, more or less, to Grantor's West property line, the tangent to the curve at this point bears North 81°28' West; thence North 00°03' West, Eighty and Nine-tenths (80.9) feet; said point lies on a regular curve to the left at which point the tangent to the curve bears North 81°21' West; thence along arc of said curve having a 5,710-foot radius Eight Hundred Ninety-one (891.0) feet; thence North 89°42' East, Two Hundred Seventy-three and Six-tenths (273.6) feet; thence South 00°02' East Eighty (80.0) feet, more or less, to point of beginning.

Based on the Utah Coordinate System, Central Zone, established by the United States Coast and Geodetic Survey the Northeast corner of said Section Thirty-three (33) has plane grid coordinates North 765,799.93 and East 1,908,157.98; the Northwest corner of said Section Thirty-three (33) has plane grid coordinates North 765,803.22 and East 1,902,846.67; the North Quarter (N1) corner of said Section Thirty-three (33) has plane grid coordinates North 765,801.36 and East 1,905,502.72 and the South Quarter (S1) corner of Section Thirty-three (33) has plane grid coordinates North 760,507.90 and East 1,905,507.90.

Ground distances in the foregoing description can be converted to U.S.C. & G.S. grid distances by multiplying by the combination factor .999712.
