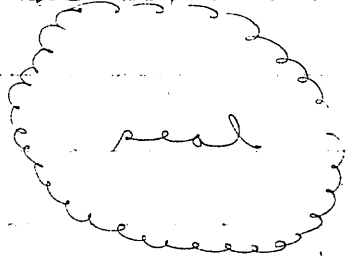


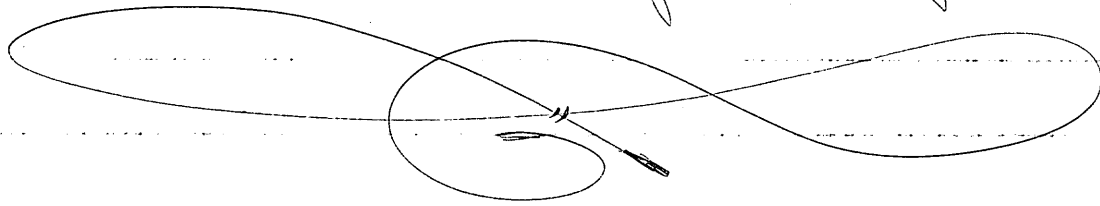

 to wit:

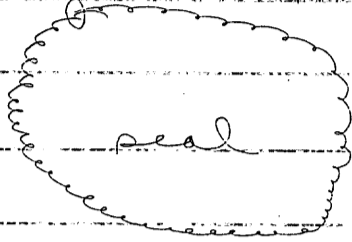

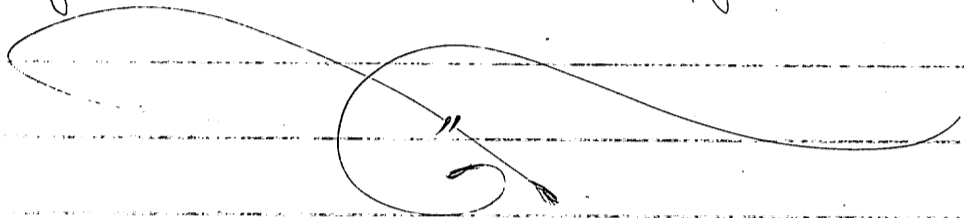

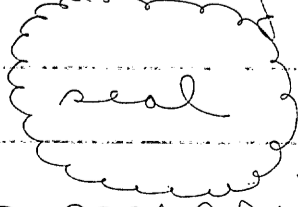
