Release and abandon a portion of a 14 foot easement 7 feet either side of the following described centerline: Beginning at a point which is South 636.74 feet and East 1482.01 feet from the Northwest corner of Section 17, T2S, R1W, SLB&M, and running thence South 17°03'53" East 322.12 feet; thence South 14°58'10" West 128.65 feet, to the center of a manhole.

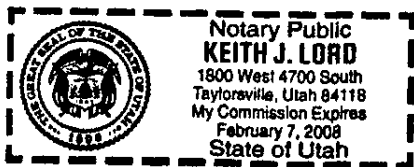
