An easement six (6) feet in width described by a center line with three (3) feet on each side as follows: Commencing North 89°56'30" East 823.9 feet and South 0°03'30" East 286 feet from Northwest corner Section 17, Township 2 South, Range 1 West, Salt Lake Base & Meridian; thence South 89°56'30" West 130.9 feet; thence South 0°03'30" East 270 feet; thence North 89°56'30" East 133.9 feet; thence South 0°03'30" East 534.25 feet to end.
