TEN AND NO/100'S AND OTHER GOOD & VALUABLE CONSIDERATION Dollars,

a temporary construction easement upon a part of an entire tract of property
situate in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 17, T.2S., R.1W., SLB&M, to facilitate the
construction of an expressway known as Project No. 1005. The boundaries of said
temporary easement are described as follows:

Beginning at the intersection of a westerly boundary line of said entire
tract and the southerly highway right of way line of said project at a point
1035.14 feet N. 89°56'30" E. along the Section line and 67.72 feet S. 0°03'30" E.
from the Northwest corner of said Section 17; thence S. 86°25'52" E. 84.24 feet;
thence N. 89°56'30" E. 228.00 feet; thence S. 73°44'44" E. 31.57 feet; thence
S. 18°05'44" E. 215.87 feet; thence S. 14°11'09" E. 125.93 feet to the southerly
boundary line of said entire tract; thence N. 89°54'30" W. 37.28 feet along said
southerly boundary line; thence N. 10°24'20" W. 217.84 feet; thence
N. 18°05'44" W. 102.05 feet; thence S. 89°56'30" W. 50.98 feet; thence
N. 0°03'30" W. 20.00 feet; thence S. 89°56'30" W. 96.79 feet; thence
S. 0°03'30" E. 20.00 feet; thence S. 89°56'30" W. 100.00 feet; thence
S. 0°03'30" E. 25.10 feet; thence N. 86°25'52" W. 89.75 feet; thence
N. 19°08'16" E. 21.99 feet along a westerly boundary line of said entire tract
to a point of tangency with a 40.00-foot radius curve to the left; thence
Northwesterly 29.63 feet along the arc of said curve and a westerly boundary line
of said entire tract to the point of beginning as shown on the official map of
said project on file in the Office of the Utah Department of Transportation.

The above described parcel of land contains 16128 square feet in area or
0.370 acre.

The above described temporary construction easement shall expire upon

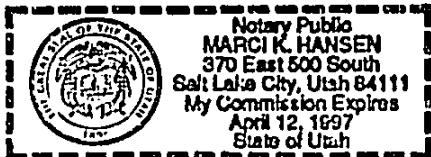

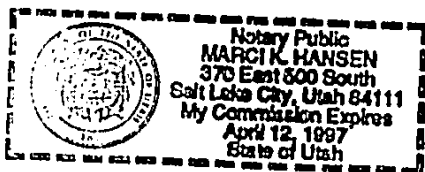
