FOURTH AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

THIS FOURTH AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS (the "Fourth Amendment") is made and executed as of the _/gt__ day of ______ 2013, by the undersigned, successor-in-title to the original Declarant (the "Declarant").

RECITALS

- A. Victory Ranch, L.C., a Utah limited liability company (the "Original Declarant") submitted that certain real property in Wasatch County to the Declaration of Covenants, Conditions and Restrictions for Victory Ranch, a Master Planned Community (the "Declaration"), recorded on June 9, 2006 as Entry No. 302853, in Book 0863, at Pages 0474 through 0554 with the Wasatch County Recorder; and
- B. The Declaration was amended by the First Amendment to Declaration of Covenants, Conditions and Restrictions (the "First Amendment") recorded June 26, 2008, as Entry No. 337433, in Book 0969, at Pages 1229 through 1249, inclusive, and by that certain First Supplemental Declaration of Covenants, Conditions and Restrictions (the "Second Amendment") recorded December 17, 2008, as Entry No. 342937, in Book 0979, at Pages 0620 through 0633, inclusive, and by the Third Amendment to Declaration of Covenants, Conditions and Restrictions (the "Third Amendment"), recorded March 27, 2012, as Entry No. 377440, in Book 1052, at Pages 835 through 847, inclusive, in the office of the Wasatch County Recorder; and

- C. VR Acquisitions, LLC, a Delaware Limited Liability Company ("Declarant") is the successor-in-interest to the Original Declarant; and
- D. Declarant remains the Owner of one or more Lots and, pursuant to Section 9.3 of the Declaration, is authorized to amend the Declaration without other consent or approval; and
- E. Declarant desires to amend the Declaration 1) to correct certain legal descriptions and clarify references to subsequent plat amendments; 2) to confirm annexation of certain property; 3) to add a definition of Easements for Ingress and Egress; 4) to allow Residences to be rented or leased for periods of no less than 30 days, and Cottage Units to be rented or leased on specified terms; and 5) to reserve the right to allow Residences owned or managed by Declarant, a Declarant Affiliate, and/or Victory Ranch Club, LLC, to be occupied by or leased to guests and prospective purchasers and investors for periods shorter than 30 days.

WITNESSETH

NOW, THEREFORE, the Declaration, as previously amended by the First Amendment, Second Amendment and Third Amendment, is hereby further amended as follows, with such amendment to become effective upon the recording of this Fourth Amendment in the offices of the Wasatch County Recorder, Utah:

- 1. <u>Corrected Legal Descriptions</u>. The legal descriptions for Victory Ranch Plats B and F as set forth in the Second Amendment are hereby corrected to read as set forth in Exhibit A to this Fourth Amendment. The Second Amendment is hereby amended to delete all references to annexation of Plat J, which Plat J will no longer be considered to have been annexed to the Property or subject to the Declaration.
- 2. <u>Subject Property</u>. Pursuant to Section 2.2.1 of the Declaration, the land described in Exhibit B to this Fourth Amendment (Victory Ranch Plat H, and Road Dedication Plat No. 3) is hereby annexed to the Property and subjected to this Declaration.
- 3. <u>Amendment to Article 1</u>. Unless otherwise specified, the definition of "Plat" in Section 1.43 shall refer to the most current recorded version of the subdivision plats, including any recorded amendments, replats or supplements to the various recorded plats, and shall not include lands removed from plats by amendment or by vacation.
- 4. <u>Further Amendment to Article 1</u>. The following Section 1.56 is added to Article 1, Definitions:
 - 1.56 "Easements for Ingress and Egress" as referred to in Section 4.3 and elsewhere in the Declaration means all land and the improvements situated thereon within the Project which the Declarant has designated on a Plat or other Recorded instrument for ingress and egress for pedestrian and/or vehicular traffic. Easements for Ingress and Egress are intended for the benefit and use of the Declarant and the Owners of Lots or Units in the Plat or Plats where the easements are identified, and for their invitees, and

not for the benefit and use of others. Easements for Ingress and Egress shall be maintained, repaired and replaced by the Association or, if a separate association exists comprised of all of the Owners of the Lots or Units in the Plat or Plats where the Easements of Ingress and Egress are located, by that association. Parking in driveways that have been designated as Easements for Ingress and Egress is permitted only as described in Section 3.23 of the Declaration, except that the approvals and rules or regulations referenced in Section 3.23 may be made by the Association or, if a separate association exists comprised of all of the Owners of the Lots or Units in the Plat or Plats where the Easements for Ingress and Egress are located, by that association. No vehicle may be parked, stored or stationed in any driveway designated as an Easement for Ingress and Egress in a manner that would block or restrict access to any Unit served by that driveway.

5. Amendment to Article 3. The first sentence of Section 3.37 is deleted in its entirety and replaced with the following: "No Residence may be leased or rented for any use other than the uses permitted herein or for any period shorter than thirty (30) days in duration, except that Cottage Units may be rented or leased on terms set forth in rules adopted by The Cottages at Victory Ranch Home Owners Association." The last sentence of Section 3.37 is deleted in its entirety and replaced with the following: "The prohibition in this Section against leases or rentals for periods of less than thirty (30) days shall not apply to Cottage Units or to Residences owned or managed by Declarant, a Declarant Affiliate, and/or Victory Ranch Club, LLC."
