-TRANSMISSION LINE EASEMENT.

Asltje L. Nyveld and D. J. Nyveld, her husband, grantors, of Weber County, Utah, hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, inspection, re-location, and replacement of the electric transmission, distribution, telephone and telegraph circuits of the Grantee, and two two poles or towers, with the necessary gays, stubs, cross-arms and other attachments thereon, or affixed thereto, for the support of said circuits, under, upon and across a tract of land fifty (50) feet in width, belonging to the Grantors, in Weber County, Utah, described as follows: Twenty-five (25) feet on each side of a line:

Commencing on the West boundary of Grantor's land at a point 510 feet (more or less) North of the South 1/4 corner Section 3, Township 5 North, Range 2 West, S. L.M.- thence running North 7° 57' East 850 feet to North boundary of Grantor's land; all contained within the Southwest 1/4 of Southeast 1/4. Section 3. said Township and Range.
