## TERMINATION OF TEMPORARY EASINGEST

whereas, the United States, Grantee, obtained a temporary easement from the Weber Basin Water Conservancy District, Grantor, during the construction of the Davis Aqueduct, Weber Basin Project, which easement was to be released when the construction work was completed through the easement area.

NOW, THEREFORE, the United States acting pursuant to the Act of Congress of June 17, 1902 (32 Stat. 388) having completed the construction work of the Davis Aqueduct and appurtenant structures through the certain easement area, does hereby release, terminate, and discharge the temporary easement obtained from the Grantor named in that certain deed dated August 31, 1954, and recorded in Book 71, Page 54, on the 22nd day of September 1954, in the Davis County Recorder's Office and described as follows:

A strip of land in the Southwest Quarter of the Northwest Quarter (SWiNWi) of Section Thirteen (13), Township Four (4) North, Range One (1) West, Salt Lake Base and Meridian, One Hundred Ninety (190.0) feet wide and included between two lines extended to the property lines and everywhere distant One Hundred (100.0) feet on the right or Westerly side and Ninety (90.0) feet on the left or Easterly side of that portion of the following described centerline of what is known as the Davis Aqueduct from Station 19940.0 to Station 206407.0 measured at right angles or radially thereto; said centerline is more particularly described as follows:

Beginning at Station 199+40.0, a point on the North line of the Grantor's property, from which point the West Quarter corner of said Section 13 bears South 46°37' West Nine Hundred Sixty-one and Six-tenths (961.6) feet; and running thence South 17°57' East Seventy-eight and Two-tenths (78.2) feet; thence along a regular curve to the right with a radius of 200.0 feet for an arc distance of Seventy-three and Threetenths (73.3) feet; thence South 3°03' West Five Hundred Fifteen and Five-tenths (515.5) feet to Station 206+07.0 of said aqueduct centerline, a point on the South line of the Grantor's property, and also being on the South line of the  $SW_{k}^{1}NW_{k}^{1}$  of said Section 13, from which point the West Quarter corner of said Section 13 bears North 89°57' West Seven Hundred Five (705.0) feet, containing 2.9 acres, more or less; excepting herefrom 0.6 of an acre, more or less, which is covered by perpetual easements and described as follows:

Beginning at Station 199+40.0, a point on the North line of the Grantor's property, from which point the West Quarter corner of said Section 13 bears South 46°37' West Nine Hundred Sixty-one and Six-tenths (961.6) feet; and running thence South 17°57' East Seventy-eight and Two-tenths (78.2) feet; thence along a regular curve to the right with a radius of 200.0 feet for an arc distance of Seventy-three and Three-tenths (73.3) feet; thence South 3°03' West Five Hundred Fifteen and Five-tenths (515.5) feet to Station 206+07.0 of said aqueduct centerline, a point on the South line of the Grantor's property, and also being on the South line of the SW\frac{1}{2}NW\frac{1}{4}\) of said Section 13, from which point the West Quarter corner of said Section 13 bears North 89°57' West Seven Hundred Five (705.0) feet.

This release shall not be construed to release or affect in any manner the perpetual easements granted by said Grantor in the above-referenced deed.
