A stream that flows through the SW 1/4 of Sec. 3, and the S 1/2 of Sec. 4 and the N.W. 1/4 of Sec. 9. Said stream originates at the ponds just west of 50 West Street and east of I-15 in Township 3 North, Range 1 West, S.L.B.M., and flows westerly to the Great Salt Lake.
