RESOLUTION NO. **775**

A RESOLUTION TO CREATE MURRAY CITY (700 WEST) SPECIAL IMPROVEMENT DISTRICT NO. 21 AND TO AUTHORIZE CONSTRUCTION OF IMPROVEMENTS AS SET FORTH IN THE NOTICE OF INTENTION TO CREATE THE SPECIAL IMPROVEMENT DISTRICT.

BE IT RESOLVED by the Mayor and City Council of Murray City, Salt Lake County, Utah:

Section 1. It will be in the best interest of said Municipality to construct the improvements identified and described in the Notice of Intention concerning the Murray City (700 West) Special Improvement District No. 21, which Notice has been published and mailed as required by law.

Section. 2. The City Council has heretofore considered each and every protest filed and has heard each and every person who wished to be heard in protest against the creation of the District or the construction of any of the improvements therein or on any other matter pertinent to said District. The protests have been referred to the Engineering Department for tabulation and recommendations.

Section 3. Improvements proposed and described in the Notice of Intention to create said Murray City (700 West) Special Improvement District No. 21 are hereby authorized, and Murray City (700 West) Special Improvement District No. 21 is hereby created to include the following:


Installation of curb, gutter and sidewalk upon all parcels of land and lots along both sides of 700 West between 5300 South and 6050 South in Murray City, Utah. Properties which have curb, gutter and sidewalk already installed shall not be required to pay for said proposed new improvements. In the event that Safer Sidewalk money becomes available, the proposed assessment for sidewalk may be eliminated or substantially reduced.

Section 4. The City Engineer is hereby instructed to prepare a notice which calls for bids for the construction of improvements contemplated to be made in Murray City (Jones Court) Special Improvement District No. 19, and the City Recorder is hereby instructed to publish the Notice to Contractors calling for bids at least one time in the Murray Eagle, a newspaper of general circulation in Murray City, at least fifteen (15) days before the date specified in the notice for the receipt of bids.



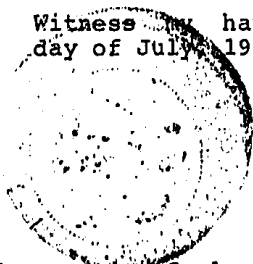
