Meadows, and Gladys Meadows, his wife, grantors of Cottonwood, County of Salt Lake, State of Utah, hereby grant, bargain and sell to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Four and no/100 (\$4.00) DOLLARS, the following described right of way across the grantors' land in Salt Lake County, State of Utah, as follows:

Right of way for highway known as W. P. S. O. No. 131-B across the grantors' land in the SE 1/4 SE 1/4 of Section 9, T. 2 S., R. 1 E., S. L. B. & M. Said right of way is a strip of land 35 ft. wide, 35 ft. on east side of the center line of survey of said project. Said center line is more particularly described as follows:

Beginning at Engineer's Station 220/38.4, which point is 659.5 ft. north and 217.8 ft. west from the SE corner of said Section 9; thence S. 1° 37' W. 148.6 ft. to the intersection of said center line of survey at Engineer's Station 221/87 and the south boundary line produced of said grantors' land, which point is 510.9 ft. north and 222 ft. west from the SE corner of said Section 9, as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described tract of land contains approximately .12 acre, of which .116 acre is now occupied by the existing highway. Balance .004 acre.

Right of way for highway known as W. P. S. O. No. 131-B across the grantor's land in the SE 1/4 SE 1/4 of Section 9, T. 2 S., R. 1 E., S.L.B. & M. Said right of way is a strip of land 35 ft. wide, 35 ft. on east side of the center line of survey of said project. Said center line is more particularly described as follows:
