Commencing at a point 1090 feet East and 33 feet North of the Southwest corner of Section 9, T 4 N R 2 W S. L. M. thence N 23° 56' W 2005 feet.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstruction which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
