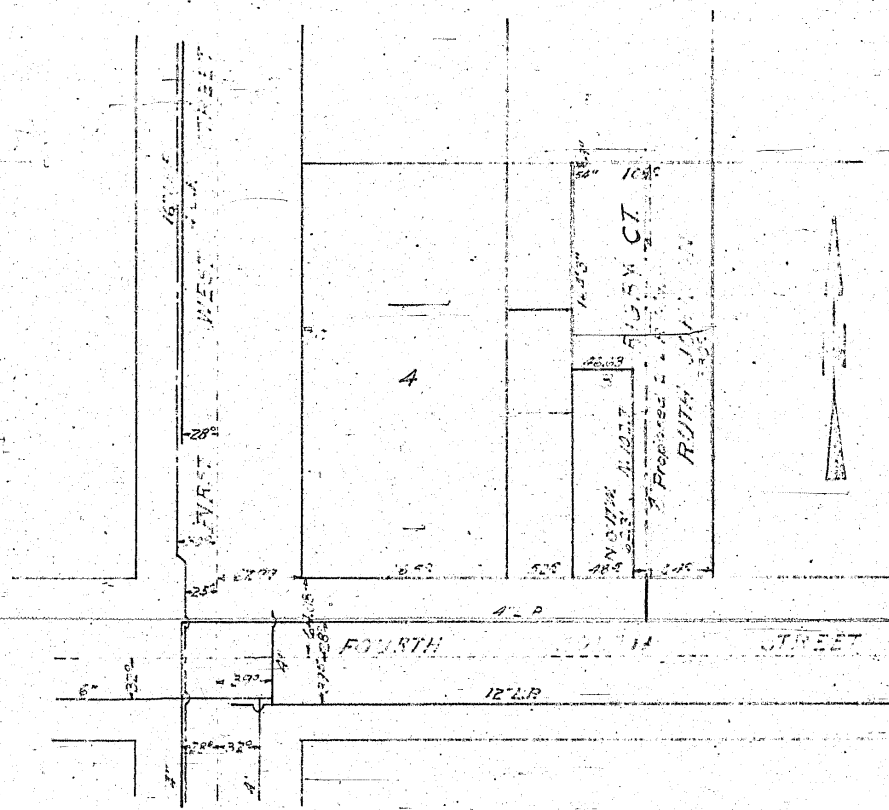

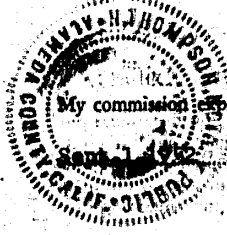

 land and premises in Salt Lake County, State of Utah to-wit:

Part of Lot 3, Block 50, Flat "A" Salt Lake City Survey.

the center line of which said gas pipe line shall extend through and across the above described land and premises on a line described as follows, to-wit:

Center line of gas main to be located as shown on attached print.

TO HAVE AND TO HOLD the same unto the said Mountain Fuel Supply Company, its successors and assigns, so long as such pipe line or lines, gates or gate boxes shall be maintained, with the right of ingress and egress to and from said right of way to maintain, operate, repair, remove, and replace the same.
