**AMENDMENT TO DECLARATION OF CONDOMINIUM  
 OF  
 OQUIRRH PARK PHASE 2 CONDOMINIUMS**

This Amendment to Declaration of Condominium of Oquirrh Park Phase 2 Condominiums is made and executed by the Oquirrh Park Phase 2 Homeowners Association, Inc., of Post Office Box 9375, Salt Lake City, UT 84109 (the "Association").

**RECITALS**

A. The Declaration of Condominium of Oquirrh Park Phase 2 Condominiums was recorded in the office of the County Recorder of Salt Lake County, Utah on September 30, 1999 as Entry No. 7478251 in Book 8312 at Page 7991 of the official records (the "Declaration").

B. This document affects the real property located in Salt Lake County, Utah, described with particularity on Exhibit "A," attached hereto and incorporated herein by this reference (the "Property").

C. All of the voting requirements to amend the Declaration set forth in Article XVII, Section 17.03 of the Declaration have been satisfied; that is, at least 67% of the total vote in the Association voted to adopt a lender foreclosure policy and amend the Declaration.

D. The Association is the managing agent of the Owners of the Property.

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Project and the Unit Owners thereof, the Association hereby executes this Amendment to Declaration of Condominium of Oquirrh Park Phase 2 Condominiums for and on behalf of and for the benefit of all of the Unit Owners.

1. Article XV of the Declaration for the Oquirrh Park Phase 2 Condominiums is hereby amended to add Section 15.05 (c) as follows:

15.05 (c) Priority of Lender/Foreclosure. Any mortgagee who obtains title to a Unit pursuant to the remedies in the mortgage or through foreclosure, or through deed in lieu of foreclosure will

be liable for all of the unpaid regularly budgeted Assessments, dues or charges accrued on the Unit before the mortgagee's acquisition of the title to the Unit. The mortgagee will also be liable for any reasonable attorney's fees or costs related to the collection of the unpaid dues.

2. In the event of any conflict, inconsistency or incongruity between the provisions of this Amendment and the provisions of the Declaration, the former shall in all respects govern and control.

3. It is expressly agreed that this amendment is supplemental to the Declaration, which is by reference made a part hereof, and all the terms, conditions, and provisions thereof, unless specifically modified herein, continue to apply and are made a part hereof as though they were expressly rewritten, incorporated and included herein.

4. The effective date of this Amendment is the date it is recorded in the office of the County Recorder of Salt Lake County, Utah.



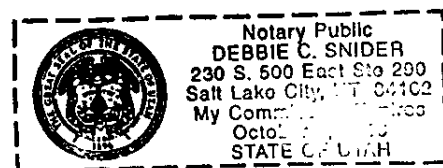
