whereby I hereby grant unto said Company, its successors and assigns, the right to construct,
operate and maintain its lines of Telephone and Telegraph, including the necessary poles, wires
and fixtures over, upon and along the public roads, streets and highways on or adjoining the
property, owned by me in the city of Salt Lake City, beginning 26.25 chains north and 4.92 chains west from the S.E. corner of the S.E. quarter of section
36, Township 1 d, Range 1 W. Salt Lake Mer. and running thence N 42° 27' 32" chains, thence N
89° 11' 59" chains to the center of the 4th and street, thence north on said street to the intersection
with the center line of the 4th street, running east and west, thence east 8.83 chains to place
of beginning.
