WARRANTY DEED.

JOHN HEIL and KATHERINE MAY HEIL, his wife grantors of Lehi, County of, Utah State of Utah, hereby Convey and Warrant to APARTMENT AND HOTEL INVESTMENT COMPANY, a corporation of Utah grantee of \_\_\_\_\_ for the sum of TEN THOUSAND (\$10,000) DOLLARS, the following described tracts of land in Utah County, State of Utah:

The Southeast 1/4 of the Northwest 1/4 and N.E.1/4 of Southwest 1/4 and Lots numbered 1-3 & 5 of Section 24, Tp. 5 S. R. 1 W., Salt Lake Meridian;

ALSO, Commencing 24 rods West and 52 rods South of the Northeast corner of the Northeast 1/4 of Section 24, Tp. 5 S. R. 1 W., Salt Lake Meridian; thence West 56 rods, thence South 48 rods, thence East 16 rods, thence North 20 rods; thence East 40 rods thence North 28 rods to the place of beginning, EXCEPTING a strip of land 1-1/2 rods in width across the N.
