The South half of the Southeast quarter of the Northwest quarter of Section 1, Township 8 South, Range 2 West, Salt Lake Base and Meridian.

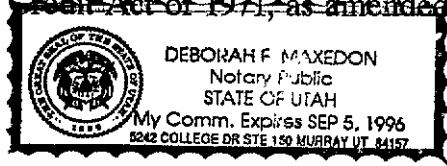
