The **UTAH DEPARTMENT OF TRANSPORTATION**, by its duly appointed Director of Right of Way, Grantor, of Salt Lake City, County of Salt Lake, State of Utah, hereby **QUIT CLAIMS** to **UTAH DEPARTMENT OF TRANSPORTATION**, Grantee, at 4501 South 2700 West, Salt Lake City, County of Salt Lake, State of Utah, Zip 84119, for the sum of \$10.00 (Ten) Dollars, and other good and valuable considerations, the following described **RIGHT OF ACCESS** to the highway in Utah County, State of Utah, to-wit:

**WHEREAS**, said UTAH DEPARTMENT OF TRANSPORTATION has certain rights of jurisdiction over the Northerly Highway Right-of-Way and No-Access Line from a point directly opposite Highway Engineer Station 55+02.2 to a point directly opposite Highway Engineer Station 61+09 of an existing highway known as Interstate 15, project No. I-15-6(30)242, situate in the SW Quarter, of the NE Quarter, of Section 1, T. 10 S., R. 1 E., S.L.B.&M., in Utah County, State of Utah, as described in that certain Warranty Deed, recorded as Entry No. 14233, in Book 985, at Page 536 Official Records.

**NOW THEREFORE**, for the consideration of the mutual benefit of the DEPARTMENT OF TRANSPORTATION and the public hereto and for other good and valuable considerations, the sufficiency of which is acknowledged, said Northerly Highway Right-of-Way and No-Access Line from a point directly opposite Highway Engineer Station 55+02.2 to a point directly opposite Highway Engineer Station 59+09.19 is hereby **REDESIGNATED** to be Highway Right-of-Way and Limited-Access Line.

**RESERVING**, said Northerly Highway Right-of-Way and No-Access Line from a point directly opposite Highway Engineer Station 59+09.19 to a point directly opposite Highway Engineer Station 61+09 as Highway Right-of-Way and No-Access Line.
